



## Annexure-I

**Name of Scheme:** Financial Assistance for School Uniforms, food, books etc for the children of registered construction workers.

**Objective:** To provide financial assistance to the registered construction workers for their children's education-related expenses such as uniforms, food, books, etc. This benefit will be provided as additional benefit along with education benefit.

**Eligibility:** (i) The construction workers who are registered under Tripura Building and Other Construction Workers Welfare Board are eligible for the scheme for their children. (ii) The maximum two children of the same parents/ guardians will be entitled to receive this benefit. (iii) The children should be studying in any recognized school or college from Class I to Diploma, Graduation, or Post-Graduation level. (iv) Certificate of the Head of Institute of School, College and university stating that the student is reading in which class during the year.

**Benefits:** The eligible beneficiary will receive an annual amount of **Rs. 2000 per child**, which will be transferred directly to their bank accounts along with education benefit. The amount can be used for any education-related expenses such as uniforms, food, books, etc.

### **Supporting Documents:**

- Bank Account Details
- Prescribed application form.
- Copy of BOC worker registration card
- Mark sheet of a student
- Any other documents as and when required.

**How to apply:** The registered beneficiary will apply in prescribed form through electronically. The concerned Labour Inspector will process and verify the application and Labour Officer will review and approved the application.
